3) Approval of 2017-2018 Breakfast and Lunch Prices **

Below are the proposed lunch prices for 2018-2019. The prices in yellow are the only prices proposed to change next year. The increase is \$.05 or 1.8%. Every year ACES is required by the USDA to submit lunch and breakfast price calculations to ensure that we charging equitable prices for our school meal program. To ensure that we are in compliance with Section 205 of the Healthy, Hunger-Free Kids Act of 2010 (Public Law 111-296), we have completed the Federal Meal Price Calculation and the results indicate that we have to increase prices in a few areas within our elementary programs. This provision requires school food authorities (SFAs) participating in the National School Lunch Program complete the calculation to ensure that schools are providing the same level of support for lunches served to students who are not eligible for free or reduced price lunches (i.e., paid lunches) as they are for lunches served to students eligible for free lunches.
