5. Executive Director's Report - Dr. Thomas M. Danehy

Dr. Thomas M. Danehy spoke about the following items:

- MSAP and AQIS Grant Awards Celebration ACES was notified of two large grant awards, \$4.4M for Wintergreen School through the federal Magnet School Advancement Grant and \$1.4M from the State of Connecticut for the early learning center quality improvement work in New Haven County.
- 2. Executive Director Goals 2022-2023 The Executive Director's goals are included in the packet. They include thematic areas in strategic design planning and lobbying efforts for three school construction projects and ACES at Chase tuition funding.
- 3. Design Plan Update The first meeting was held on October 6, and the next is scheduled for November 17. The Design Team expects to complete all phases of the work in early February 2023.
- 4. Non-bargaining Employees' Compensation Proposal 2023-2024 Proposal will be included in the November Board packet and includes general wage and step increases to coincide with economic trends.
- 5. RESC Alliance Work Ignite Change and RESC funding The Ignite Change conference looks successful, given the number of registrants. The RESC Alliance's work centers on issues each RESC can better address through collective collaboration.

6. Filing of the Fiscal Report (subject to audit) - Mrs. Simoes/Ms. Harris

October projections reflect a surplus based on the projected revenues, encumbrances, and expenditures. We anticipate these projections will fluctuate as we finalize the magnet school student enrollment report, review projected special education school enrollment, and settle service contract numbers. ACES schools and programs continue to evaluate their staffing and supplies/materials needs. September billing has been completed and reflected in the billed-to-date column of the fiscal report along with the projected revenues, which presents a positive outlook for the year-end cash flow position.

Mr. Rice reported on the upcoming events of Magnet and Specialized Schools. ACES Wintergreen was awarded the MSAP Grant to focus on improving the arts integration practices of teachers, academic achievement, and increasing enrollment and diversity. ACES continues to hold Vaccine Clinics at several of the schools. RESC Alliance is working with CSDE - Literacy Center on how to respond to the mandate that requires all K-3 classrooms in CT to use reading programs identified by the CSDE. Connecticut Approved K–3 Core Comprehensive Reading Curricula/Programs Under C.G.S. Sec. 10-14ii, the following curricula/programs, listed in alphabetical order, fully meet the expectations of the 2022 Guidelines and are approved for use by districts until June 30, 2027:
