# 4. Executive Director's Report

Dr. Danehy gave an update on the RESC Regional Reopening Committee work. The committee has met three times and is awaiting on more direction from the State. We did receive guidance on summer school criteria. The RESC groups will be kept in place should the Sate want to use them to review information in the future.

The ACES Internal Reopening Group is preparing for the July 6<sup>th</sup> Extended School Year using a distance learning model with services provided as needed for OT and PT. Whitney High School North will be the in person learning pilot for this program.

Mrs. Simone & Mr. Howes explained each budget in detail to the Board.

## 5. Filing of the Fiscal Report (subject to audit)\*\*-Mrs. Simoes/Ms. Riccio

At the end of May, our bottom line projections reflect a slight deficit as we are getting to the end of the fiscal year while adjusting operations to comply with the federal and state guidelines as it pertains to preparations for the agency reopening during COVID 19. We have continued to work with our districts to provide information related to invoicing for tuition and services to ensure a fair and equitable solution for all concerned. Our expenditures primarily focused around PPE acquisition and necessary to support the continuation of teaching and learning, providing services and outreach. Our goal is to get to a break-even point or slight surplus by the end of the year.
