2. PROJECT DESCRIPTION

The work consists of various levels of alterations to 6 Buildings located on campus that were built approximately from 1927 – 1974 with larger additions and various renovations added to the Main, Lower School and Upper Schools. **The Main School** will have interior structural alterations, all new interior finishes with new roof, MEPFPT, electrical service and elevator and some façade alterations, **Library** will have complete interior reconfiguration, new elevator, new MEPFP, electrical service, finishes, **Music Hall** will have interior structural alterations, MEPFPT, electrical service, finishes as well as a new addition with an elevator and accessibility ramp. **Lower & Upper Schools** will have varying levels of scope for new finishes, MEPFPT, some structural work and will be occupied by students and staff. **The Gymnasium** will have new lockers, bath, some new MEPFPT, replacement of gym ceiling system. The **Site** will consist of varying new utility services, storm drainage, enlargement of main parking area and the addition of a bus loop as well as varying walk paths, retaining walls and landscape.

5. BID FORM – All bids for all bid packages are to be submitted by mail or via hand delivery, with all spaces filled in. Faxed bids will be rejected. Those bidders who are bidding more than one Bid Package Scope of Work should submit their bids on separate Bid Forms in separate, sealed envelopes unless they are submitting combined bids for which a space has been provided. 

The Prevailing wage rates applicable to this project are subject to annual adjustments each July 1st for the duration of the project.

Each contractor shall pay the annual adjusted prevailing wage rate that is in effect each July 1st, as posted by the Department of Labor.

It is the contractor's responsibility to obtain the annual adjusted prevailing wage rate increases directly from the Department of Labor's website.

The Department of Labor will continue to issue the initial prevailing wage rate schedule to the Contracting Agency for the project.

Contracting Agencies are under no obligation pursuant to State labor law to pay any increase due to the annual adjustment provision.

Effective October 1, 2005 - Public Act 05-50: any person performing the work of any mechanic, laborer, or worker shall be paid prevailing wage

All Person who perform work ON SITE must be paid prevailing wage for the appropriate mechanic, laborer, or worker classification.

All certified payrolls must list the hours worked and wages paid to All Persons who perform work ON SITE regardless of their ownership i.e.: (Owners, Corporate Officers, LLC Members, Independent Contractors, et. al)

Reporting and payment of wages is required regardless of any contractual relationship alleged to exist between the contractor and such person.

--Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clause (29 CFR 5.5 (a) (1) (ii)).
