1. Call to Order

Norm Hicks called the ACES Governing Board meeting to order at 12:17 PM after determining a quorum was present.

2. Pledge of Allegiance

3. Public Participation/Communications

- John Prins, CABE presented Jim Hoko The 2017 Bonnie B. Carnie Award of Excellence for educational communications for the ACES Behavioral Services Catalog. Dr. Danehy commended Dr. Hoko and Dr. Rossetti-Ryan for their work on the catalog.
- Carol May, Todd Solli and WIMS students provided a brief demonstration on coding. The Osmo devices used were purchased with funds awarded from the ACES Education Foundation.
- Mr. Hicks welcomed Tom Buzzelli, alternate from Wolcott.

- Mr. Hicks shared thank you notes from Mr. Marcucio and Ms. Logan. Mr. Hicks also thanked the Board for the recent gift.
- Mr. Hicks offered congratulations to Ethel Grant for the recent award from the CT State Democrats for her remarkable humanitarian efforts in the greater Naugatuck community.
- Susan Riccio commented that the ACES Education Foundation Gala was amazing with funds supporting ACES programming.

5. Executive Director's Report

- 1) Update on Leeder Hill Renovation Project: Tim Gunn, ACES and David Klein, Silver Petrucelli provided an update on the renovation project indicating the project is on target and is within budget.
- 2) Update on Real Estate: Dr. Danehy reported that after interviewing firms, ACES is working with Dow Realty to plan for the properties that will become vacant once Leeder Hill is completed as well Central Office and Technology Services.
- 3) Update ACES Education Foundation Gala: Dr. Danehy reported an estimate of \$114,000.00 was raised of which \$74,000 came from corporate sponsorships. Dr. Danehy thanked Dr. Rossetti-Ryan and Mr. Gunn for securing many of the sponsors. The event hosted over 350 attendees. ACES will be able to award grant funds to ACES schools and programs to enrich and enhance educational experiences to our students and clients.

8. Filing of Fiscal Report (subject to audit)

The Executive Director recommended that the ACES Governing Board approve the filing of the Fiscal Report (subject to audit).

Ms. Riccio reviewed the Fiscal Report and indicated that the financial position has crossed over into positive territory. Student enrollment in the special education schools has increased and ACES has received additional contracts within the services group which enhances our surplus. The Choice Program has been awarded the supplemental funds from the State for transportation brining the revenue and expenses in line for the program. Through expense management ACES has identified savings in salaries, wages and health insurance costs to bring us into a surplus position. As the final months of the school year follow, ACES will continue to manage expenses, enroll students and procure new contracts to strengthen our financial standing.

This added support will allow the department to award new grants in the future.

11. Early Head Start Update

The Executive Director requested the approval of the Early Head Start monthly report.

Eligibility, Recruitment, Selection, Enrollment, and Attendance

- Monthly Early Head Start (EHS) enrollment was 60 for the period:
 - o 56 children and 4 expectant families enrolled
- The program received 8 new referrals (8 Middletown) and completed 4 eligibility intakes
- There are 5 families pending eligibility determination.
- The program has 0 eligible families on the wait list. There 2 Over Income families on a waitlist.
- The program has 11 children enrolled with IFSPs, meeting and exceeding the 10% requirement.

• 3 children and 1 expectant mother exited the program during this period. (1 child transitioned to preschool, 1 pregnant mother delivered, 1 family moved. 1 family requested to be discharged due to other commitments).

Policy Council Updates

- Policy Council met March 28th at the ACES Education Center 300 Washington, Middletown. There was no quorum and members agreed to meet again April 4th to discuss and vote on pressing business.
- Members of the policy council received a 2nd quarter monitoring update in which all programmatic content areas were discussed. Of our 60 children, 3 were not up to date with their health and developmental screenings. The goal is to work with providers and families to ensure these children receive their screenings on time. In these cases, attendance was a significant factor.
- A recruitment plan was reviewed with the policy council to bring attention to target areas prioritized by the Early Head Start Program. We need to increase the number of families from the shoreline. In addition, there is a need to strengthen relationships with the foster care system.
- Policy council reviewed updated procedures for reimbursement, purchases, and in-kind contributions.
- Policy council received information on a reported Middlesex Hospital deficit. The hospital over spent beyond their contracted amount. Rebecca Cuevas, Early Head Start Coordinator, was informed of this over spending on March 9, 2018. Middlesex Hospital stated, at this meeting, that they had made a fiscal mistake. Much of the increase in spending was determined to be attributed to merit raises and fringe benefits that were never disclosed to Rebecca Cuevas or policy council. The federal leaders for Region 1 were contacted for guidance and have supported that ACES Early Head Start use a small amount of their carry-over balance designated for special projects to help the hospital for the 2018 period. Rebecca Cuevas, with approval from the policy council, proposes giving the hospital \$8,000. The hospital would have to replace \$26, 897. The federal officers reinforced ACES Early Head Start to move with caution as they believe the hospital broke the terms of their contract with ACES and should not expect additional funds from the federal grant. Any additional funds provided by ACES Early Head Start are meant to alleviate the impact to program services. A report of staff salary of benefits is available for the governing board to review. Tim Howes, Assistant Executive Director, and Kolby Bowen, System Program Specialist joined Rebecca Cuevas and Middlesex Hospital on March 15th to discuss the hospital's fiscal reporting moving forward. The remainder of the funds in the carry-over proposal are to complete the flooring on the second floor of 300 Washington Street, Middletown and to implement the federally mandated plan for practice based coaching.

Program Updates/Activities

- The Early Head Start socialization playgroups were held at our three locations (Middletown Community Education Center/EHS Site, Russell Library, and Grace Episcopal).
- The Early Head Start program hosted weekly Circle of Security sessions facilitated by Nurturing Families.

- The CT Birth to Three Program Rehabilitation Associates facilitated their weekly therapeutic playgroups onsite.
- Wesleyan University presented a mini workshop to introduce the content being offered to Early Head Start families on March 27th. The first session for families of the Lullaby project begins April 3rd. Five Wesleyan students were selected to facilitate the program. Through the Lullaby Project pregnant women and new mothers are invited to create personal lullabies for their babies with the help of professional musicians. It is intended to promote maternal health, child development, and parent-child attachment.

12. Healthy Food Certification

The Executive Director recommended that the ACES Governing Board approve the following motions:

Language for Healthy Food Option: Pursuant to C.G.S. Section 10-215f, the board of education or governing authority certifies that all food items offered for sale to students in the schools under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards during the period of July 1, 2018, through June 30, 2019. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to, school stores, vending machines, school cafeterias, and any fundraising activities on school premises sponsored by the school or by non-school organizations and groups.

Exemption for Food Items: *If the board votes "yes" for the healthy food option, the board must also vote "yes" or "no" on whether to allow food exemptions.*

Language for Exemption for Food Items: The board of education or governing authority will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards provided that the following conditions are met: 1) the sale is in connection with an event

occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the food items are not sold from a vending machine or school store. An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held.

Language for Beverage Exemptions: The board of education will allow the sale to students of beverages not listed in Section 10-221q of the Connecticut General Statutes provided that the following conditions are met: 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the beverages are not sold from a vending machine or school store. An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting or extracurricular activity. The "school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held, and must be the same place as the food sales.
